Administered by the U.S. Department of the Treasury, OFAC enforces economic and trade sanctions aligned with U.S. foreign policy and national security goals. The SDN List includes individuals, organizations, and entities whose assets are blocked, and with whom U.S. persons are generally prohibited from conducting business.

By embedding this powerful compliance tool into the Sunlight platform, we ensure that customer records, claims, and payments are automatically and manually screened against the SDN List using OFAC's publicly available data. This screening is seamlessly integrated across both Commercial and Personal product lines.

How It Works

The OFAC Check Functionality operates across key business workflows in Sunlight, including:

- New customer onboarding
- Claims processing
- Payment issuance

Whenever a new record is entered, the system automatically checks it against the SDN List. If a potential match is found, Sunlight generates a task for further review and records the outcome, ensuring full transparency and auditability throughout the process.

Additionally, any custom workflows required by specific carriers, MGAs, or insurers to support Anti-Money Laundering (AML) compliance based on OFAC check results can be easily configured within the platform to align with unique business processes.
